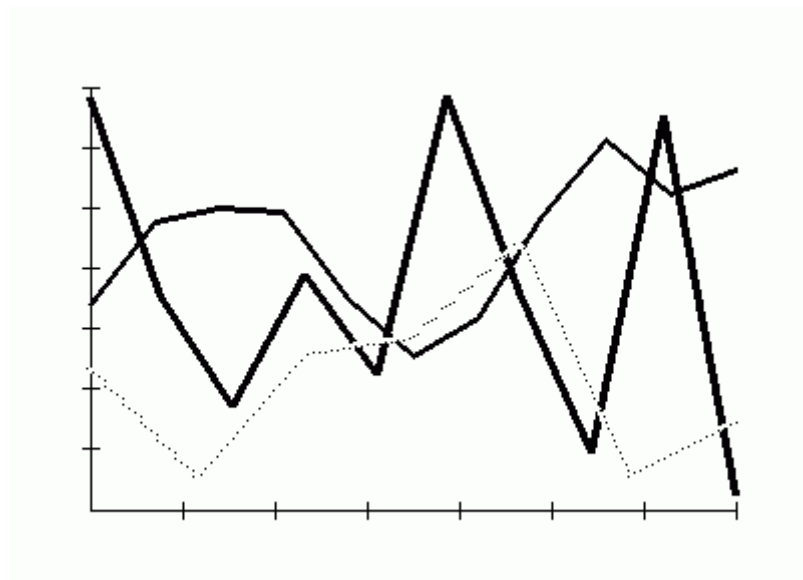

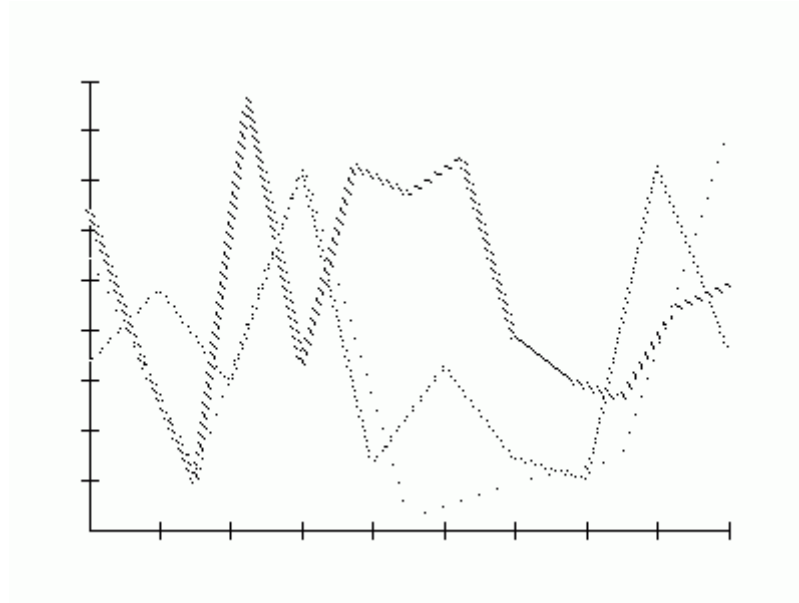

In May 2020, Musk told workers that they could stay home if they felt uncomfortable coming back to work. But in June, Tesla dismissed an employee who criticized the company for taking inadequate safety measures to protect workers from the coronavirus at the Fremont Factory. Three more employees at Tesla's Fremont Factory claimed they were laid off for staying home out of fear of catching COVID-19. This was subsequently denied by Tesla, which even stated that the employees were still on the payroll. COVID-19 cases at the factory grew from 10 in May 2020 to 125 in December 2020, with about 450 total cases in that time out of the approximately 10,000 workers at the plant (4.5%)."*

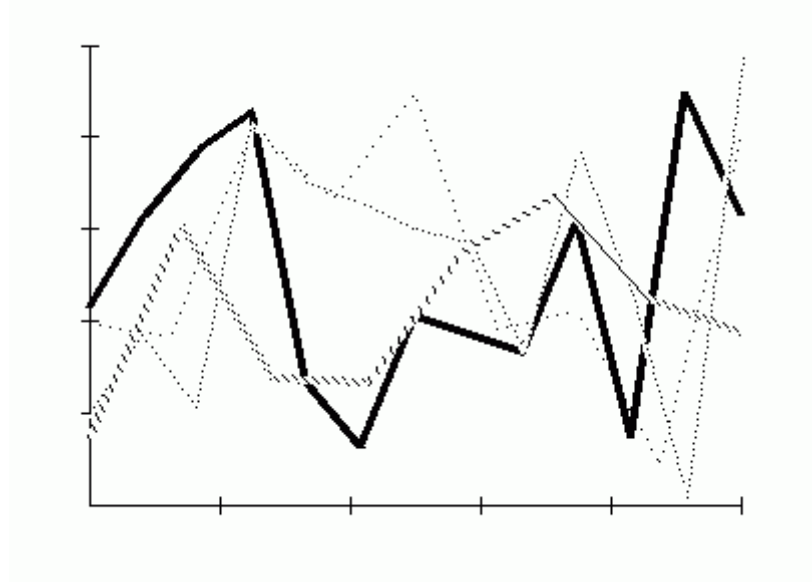

History Bitcoin Group was founded in 2014 as a bitcoin mining company as a result of a partnership between Sam Lee, Allan Guo and Vincent Vu. As of September 2015, with seven bitcoin mining locations in Australia, China, and Thailand, Bitcoin Group's mining operation generated 6.2 peta hashes, approximately 15.7% of the Global Hash Power. The company made a submission to the Australian Senate's Economics References Committee for their 2015 inquiry into digital currencies. The submission advised the committee that while the company did not agree with the ruling on the GST treatment of digital currencies by the Australian Taxation Office, its ambitions would have been more difficult to realize without the regulatory clarity that it provided."*

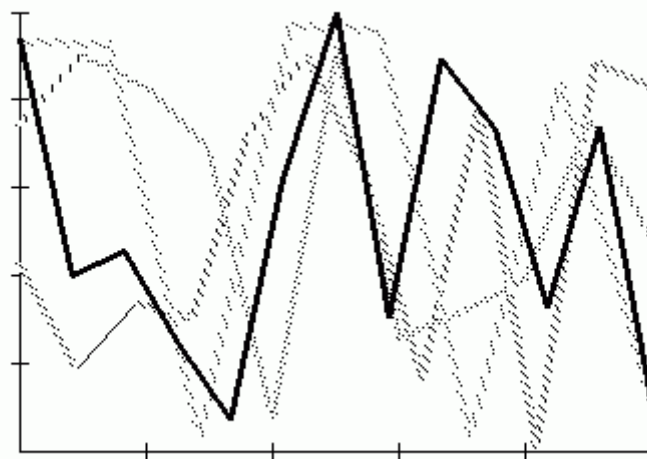

On September 1, 2021, Arcaro pleaded guilty of criminal charges pressed by the DOJ which includes conspiracy to commit wire fraud and criminal forfeiture. The DOJ also indicted Kumbhani on various federal charges in February 2022, including money laundering and fraud. On January 12, 2023, a federal district court in San Diego ordered that Arcaro pay \$17 million in restitution to be distributed to approximately 800 victims. He also agreed to forfeit more than \$24 million, which could also be used in the future to repay victims.
