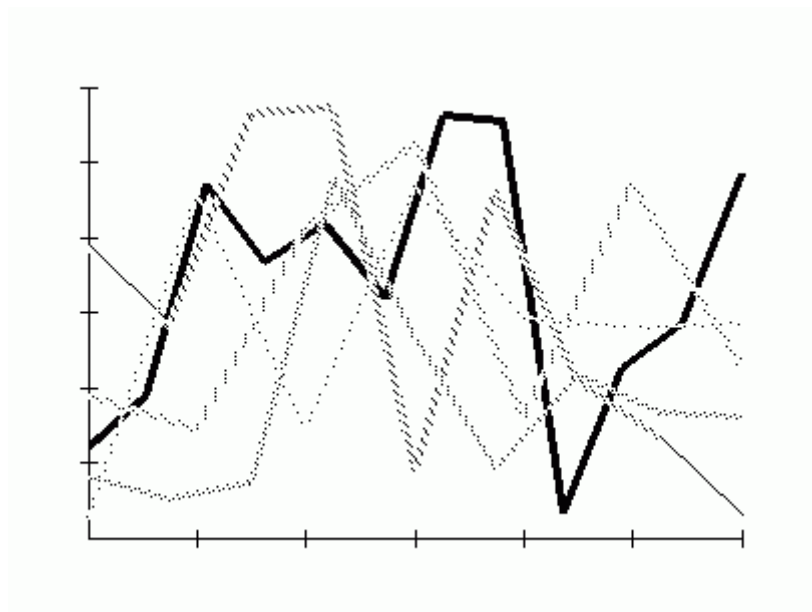

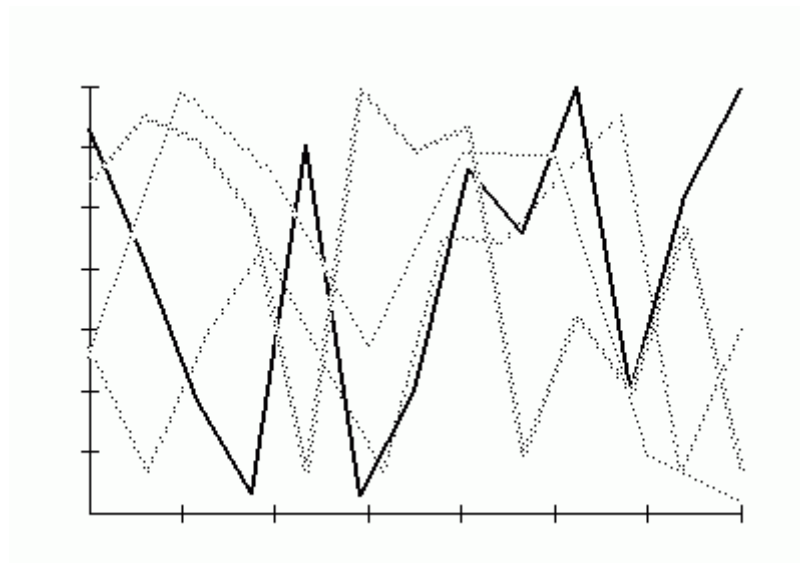

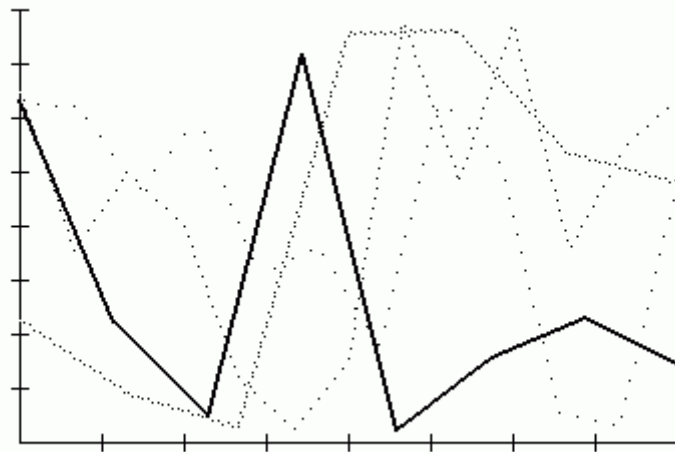

The charges reported that as SafeMoon's market capitalization exceeded \$8 billion, they fraudulently diverted millions of dollars from the 'locked' liquidity for personal gain. Karony and Smith were arrested, while Nagy remained at large. The charges were brought by the SEC and the Department of Justice with FBI assistance. In December 2023, SafeMoon declared Chapter 7 bankruptcy, and as a part of this process was acquired by the VGX Foundation. In 2024 Kyle Nagy resurfaced in Russia, where he filed a complaint with police against two men in the Federal Security Service who extorted 4.5 million dollars from him as "payment for his peaceful stay in the Russian Federation."
